**Field Crops**

Cotton harvested is 55 percent complete across the State. Cotton condition is mostly fair to good. Alfalfa harvest is decreasing, but was still active on three quarters of the State's acreage. Alfalfa condition remains mostly fair to good. Range and pasture conditions across the State vary from poor to good, depending on location and elevation.

**Vegetables, Fruit & Specialty Crops**

Last week central Arizona growers shipped cantaloupes, honeydews, and lemons. Western growers shipped cantaloupes, honeydews, spinach, and lemons last week.

**Weather Summary**

Temperatures were above normal across the State for the week ending November 4. Temperatures ranged from 3 degrees above normal at Canyon De Chelly to 9 degrees above normal at various locations. The highest temperature of the week was 97 degrees at Phoenix and

Yuma, and the lowest reading occurred in Grand Canyon at 20 degrees. No precipitation was reported at any of the 22 reporting stations. Two stations are currently above normal precipitation for the year to date.
