Florida Cattle

Florida ranked 21st in cattle operations. There were 18,900 operations in 2007 which was 2.0 percent of the U.S. total.

Florida ranked 15th in the nation in beef cow operations with 15,500 operations, 2.0 percent of the U.S. total.

Florida ranked 12th in beef cows with an inventory of 936,000, 6.8 percent of the U.S. total.

The 2007 calf crop totaled 900,000, which was 15th in the nation and 2.4 percent of the U.S. total.

Florida ranked 18th in cow inventory, 1,060,000 head, which was 1.3 percent of the U.S. total.


