

Farmers in the Commonwealth voluntarily participate in quarterly agricultural labor surveys in January, April, July and October. This survey provides data concerning the number of hired farm workers, hours worked, and wage rates. The survey reference week is the seven-day period (Sunday through Saturday) which includes the 12th day of the month. Results for Pennsylvania are published as part of Northeast II Region, which includes Delaware, Maryland, New Jersey and Pennsylvania.

The total number of workers hired by farm operators in the Northeast II Region during 2000 ranged between a

low of 27,000 in January to a high of 54,000 in July. The average hours worked during the survey week by the hired workers varied from 36.0 hours in January, 2000 up to 41.7 hours in April and July, 2000.

In 2000 all hired workers earned between \$7.84 per hour in April to \$8.33 in January. During the same period field workers hourly wage rate ranged between \$7.44 in October and \$7.84 in January. In contrast livestock workers hourly wage rates ranged between \$6.00 in April and \$6.67 in October.
