Certified Organic Highlights

The 2015 Certified Organic Survey is a survey of all operations identified as having certified organic production. Certified organic farms must meet the standards set out by USDA’s Agricultural Marketing Service’s (AMS) National Organic Program (NOP) and be certified compliant by an approved agent of NOP. Results from the survey provide acreage, production, and sales data for a variety of certified organic crops and certified organic livestock.

In 2015, the United States had 12,818 certified organic farms that produced \$6.2 billion in certified organic products. Georgia had 95 certified organic farms with 3,161 acres of certified land that produced \$20.0 million in certified organic products. Of those farms in Georgia, 25 percent were certified organic for 10 years or more.

In Georgia, 31 certified organic farms sold to wholesale markets, 61 farms sold directly to consumers, and 49 farms sold directly to retail markets and institutions. The first point of sales for 83 percent of certified organic farms in Georgia was within 100 miles of the farm and 24 percent was within 100-499 miles of the farm. Over the next five years, 63 percent of certified organic operations in Georgia plan to increase certified organic agricultural production.
