California Milk Production

California milk producers had a total of 1.76 million milk cows for January that produced 3.41 billion pounds of milk. Milk production is up 1 percent from December, 2016 and down 1 percent from January 2016. Monthly milk per cow averaged 1,945 pounds, up 20 pounds from December 2016.
