# **United States Commercial Slaughter**

Commercial red meat production for the United States totaled 4.67 billion pounds in August 2023, down 3 percent from the 4.83 billion pounds produced in August 2022.

Beef production, at 2.36 billion pounds, was 6 percent below the previous year. Cattle slaughter totaled 2.89 million head, down 6 percent from August 2022.

Veal production totaled 4.20 million pounds, 9 percent below August a year ago. Calf slaughter totaled 26,600 head, down 22 percent from August 2022.

Pork production totaled 2.29 billion pounds, down slightly from the previous year. Hog slaughter totaled 11.1 million head, up 1 percent from August 2022.

Lamb and mutton production, at 10.5 million pounds, was down 10 percent from August 2022. Sheep slaughter totaled 183,800 head, 1 percent above last year.

## **Pacific Region Commercial Slaughter**

California's production of red meat during August 2023 totaled 111 million pounds (dressed weight), 28 percent below than August 2022. This figure includes slaughter in Federally-inspected and state-inspected plants, but excludes farm slaughter. In August 2023, the average live weight of cattle slaughtered in California was 1,339 pounds, sheep and lambs averaged 140 pounds, and hogs averaged 221 pounds. In Hawaii, 800,000 pounds of red meat were produced in August 2023, and 100,000 pounds of red meat were produced in Nevada.
