KANSAS CROP PROGRESS AND CONDITION

MANHATTAN, Kan. April 29, 2019 - For the week ending April 28, 2019, there were 6.2 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 1 percent very short, 14 short, 77 adequate, and 8 surplus. Subsoil moisture supplies rated 1 percent very short, 6 short, 83 adequate, and 10 surplus.

Field Crops Report: Soybeans planted was 2 percent, equal to both last year and the five-year average.

Winter wheat condition rated 3 percent very poor, 8 poor, 31 fair, 48 good, and 10 excellent. Winter wheat jointed was 64 percent, ahead of 50 last year, but behind 75 average. Headed was 4 percent, near 2 last year, but behind 22 average.

Corn planted was 31 percent, ahead of 25 last year, but behind 36 average. Emerged was 3 percent, near 5 last year, and behind 14 average.

Data for this news release were provided at the county level by USDA Farm Service Agency, KSU Extension Service, and other reporters across the State.
