## KANSAS CROP PROGRESS AND CONDITION

**MANHATTAN, Kan. June 8, 2020** - For the week ending June 7, 2020, there were 6.2 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 9% very short, 29% short, 58% adequate, and 4% surplus. Subsoil moisture supplies rated 8% very short, 24% short, 65% adequate, and 3% surplus.

**Field Crops Report:** Winter wheat condition rated 8% very poor, 16% poor, 34% fair, 36% good, and 6% excellent. Winter wheat headed was 98%, near 96% last year, and equal to the five-year average. Coloring was 61%, well ahead of 40% last year, but near 63% average. Mature was 4%.

Corn condition rated 2% very poor, 5% poor, 33% fair, 53% good, and 7% excellent. Corn planted was 97%, ahead of 86% last year, and near 94% average. Emerged was 86%, ahead of 69% last year, and near 83% average.

Soybean condition rated 0% very poor, 2% poor, 31% fair, 63% good, and 4% excellent. Soybeans planted was 79%, well ahead of 42% last year and 55% average. Emerged was 59%, well ahead of 22% last year and 37% average.

Sorghum condition rated 1% very poor, 4% poor, 43% fair, 50% good, and 2% excellent. Sorghum planted was 51%, well ahead of 20% last year, and ahead of 37% average.

Cotton condition rated 0% very poor, 3% poor, 38% fair, 55% good, and 4% excellent. Cotton planted was 94%, well ahead of 68% last year and 65% average. Squaring was 1%.

Sunflowers planted was 49%, ahead of 32% last year and 31% average.

**Pasture and Range Report:** Pasture and range conditions rated 2% very poor, 9% poor, 34% fair, 52% good, and 3% excellent.
