KANSAS CROP PROGRESS AND CONDITION

MANHATTAN, Kan. November 2, 2020 - For the week ending November 1, 2020, there were 4.4 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 22% very short, 40% short, 34% adequate, and 4% surplus. Subsoil moisture supplies rated 19% very short, 43% short, 37% adequate, and 1% surplus.

Field Crops Report: Winter wheat condition rated 6% very poor, 17% poor, 49% fair, 25% good, and 3% excellent. Winter wheat planted was 95%, near 92% last year, and ahead of 90% for the five-year average. Emerged was 77%, ahead of 69% last year and 71% average.

Corn harvested was 90%, ahead of 80% last year, and near 86% average.

Soybeans harvested was 83%, ahead of 66% last year and 72% average.

Sorghum harvested was 74%, ahead of 64% last year and 62% average.

Cotton condition rated 3% very poor, 10% poor, 41% fair, 42% good, and 4% excellent. Cotton bolls opening was 96%, near 99% last year and 93% average. Harvested was 20%, ahead of 15% last year and 14% average.

Sunflowers harvested was 68%, ahead of 57% last year and 52% average.

Pasture and Range Report: Pasture and range conditions rated 11% very poor, 20% poor, 43% fair, 24% good, and 2% excellent.
