KANSAS CROP PROGRESS AND CONDITION

MANHATTAN, Kan. June 28, 2021 - For the week ending June 27, 2021, there were 5.4 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 3% very short, 21% short, 71% adequate, and 5% surplus. Subsoil moisture supplies rated 2% very short, 19% short, 76% adequate, and 3% surplus.

Field Crops Report: Winter wheat condition rated 3% very poor, 10% poor, 25% fair, 50% good, and 12% excellent. Winter wheat coloring was 98%. Mature was 83%, near 87% last year. Harvested was 41%, near 44% last year, and behind 48% for the five-year average.

Corn condition rated 1% very poor, 5% poor, 25% fair, 61% good, and 8% excellent. Corn silking was 8%, equal to last year, and behind 13% average.

Soybean condition rated 3% very poor, 3% poor, 30% fair, 61% good, and 3% excellent. Soybeans planted was 95%, near 97% last year, and equal to average. Emerged was 86%, behind 92% last year, and near 87% average. Blooming was 15%, ahead of 7% last year and 6% average.

Sorghum condition rated 1% very poor, 3% poor, 23% fair, 68% good, and 5% excellent. Sorghum planted was 94%, equal to last year, and near 93% average.

Cotton condition rated 1% very poor, 5% poor, 46% fair, 46% good, and 2% excellent. Cotton squaring was 29%, near 25% last year, and ahead of 18% average.

Sunflowers planted was 89%, near 87% last year, and ahead of 84% average.

Pasture and Range Report: Pasture and range conditions rated 1% very poor, 7% poor, 31% fair, 54% good, and 7% excellent.
