KANSAS CROP PROGRESS AND CONDITION

MANHATTAN, Kan. October 11, 2022 - For the week ending October 9, 2022, there were 6.5 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 52% very short, 29% short, 18% adequate, and 1% surplus. Subsoil moisture supplies rated 55% very short, 31% short, 14% adequate, and 0% surplus.

Field Crops Report: Winter wheat planted was 50%, behind 60% last year, and near 54% for the five-year average. Emerged was 19%, behind 29% last year and 31% average.

Corn mature was 95%, near 97% last year and 93% average. Harvested was 61%, near 64% last year, but ahead of 54% average.

Soybean condition rated 22% very poor, 24% poor, 29% fair, 23% good, and 2% excellent. Soybeans dropping leaves was 82%, equal to both last year and average. Harvested was 30%, ahead of 25% last year and 21% average.

Sorghum condition rated 22% very poor, 32% poor, 25% fair, 20% good, and 1% excellent. Sorghum coloring was 96%, near 99% last year and 98% average. Mature was 70%, behind 79% last year, and near 72% average. Harvested was 25%, behind 30% last year, but ahead of 19% average.

Cotton condition rated 12% very poor, 46% poor, 25% fair, 15% good, and 2% excellent. Cotton bolls opening was 81%, equal to last year, and ahead of 73% average. Harvested was 16%, ahead of 2% both last year and average.

Sunflowers harvested was 14%, behind 25% last year, and equal to average.

Pasture and Range Report: Pasture and range conditions rated 46% very poor, 28% poor, 18% fair, 8% good, and 0% excellent.
