## KANSAS CROP PROGRESS AND CONDITION

**MANHATTAN, Kan. October 30, 2023** - For the week ending October 29, 2023, there were 5.2 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 27% very short, 36% short, 34% adequate, and 3% surplus. Subsoil moisture supplies rated 33% very short, 40% short, 27% adequate, and 0% surplus.

**Field Crops Report:** Winter wheat condition rated 18% very poor, 18% poor, 32% fair, 29% good, and 3% excellent. Winter wheat planted was 91%, ahead of 85% last year, and near 87% for the five-year average. Emerged was 70%, ahead of 56% last year and 65% average.

Corn harvested was 89%, equal to last year, and ahead of 84% average.

Soybeans harvested was 80%, near 77% last year, and ahead of 66% average.

Sorghum mature was 96%, equal to both last year and average. Harvested was 69%, near 66% last year, and ahead of 59% average.

Cotton condition rated 6% very poor, 18% poor, 39% fair, 34% good, and 3% excellent. Cotton harvested was 35%, behind 49% last year, but ahead of 18% average.

Sunflowers harvested was 74%, ahead of 62% last year and 56% average.

**Pasture and Range Report:** Pasture and range conditions rated 25% very poor, 30% poor, 32% fair, 12% good, and 1% excellent.
