Broiler-Type Eggs Set Up 4 Percent from Last Year

Mississippi hatcheries set 17.3 million broiler-type eggs during the week ending February 10, 2024, up 4 percent from the comparable week in 2023 and up slightly from the previous week.

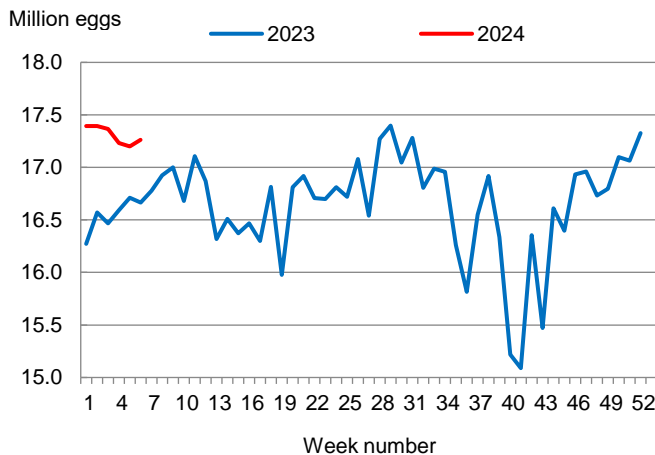
Hatcheries in the United States weekly program set 242 million eggs in incubators during the week ending February 10, 2024, down slightly from a year ago.

Broiler-Type Chicks Placed Down 3 Percent

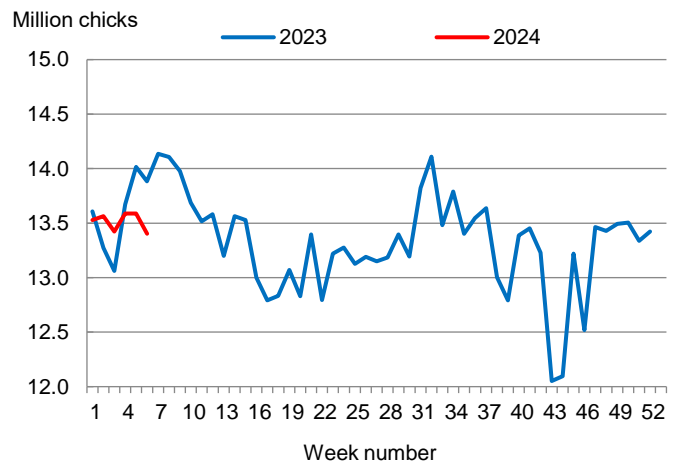
Mississippi broiler-type chicks placed for meat production were 13.4 million chicks during the week ending February 10, 2024, down 3 percent from the comparable week in 2023 and down 1 percent from the previous week.

Broiler growers in the United States weekly program placed 185 million chicks for meat production during the week ending February 10, 2024, down 1 percent from a year ago.
