## November Egg Production Up 8 Percent from Last Year

Egg production in Mississippi totaled 123 million eggs during November 2022, down 1 percent from the previous month but up 8 percent from November 2021. The number of layers during November 2022 averaged 5.76 million, up slightly from the previous month and up 4 percent from this time last year. Egg production per 100 layers averaged 2,130 eggs, down 2 percent from the previous month but up 4 percent from a year ago.

United States egg production totaled 8.87 billion during November 2022, down 5 percent from last year. The average number of layers during November 2022 totaled 375 million, down 4 percent from last year. November egg production per 100 layers was 2,369 eggs, down slightly from November 2021.

## Broiler-Type Chicks Hatched Down Slightly

Broiler-type chicks hatched in Mississippi during November 2022 totaled 57.2 million, down slightly from November 2021.

Broiler-type chicks hatched in United States during November 2022 totaled 810 million, up 1 percent from November 2021.
