



Missouri Grain Stocks

Released September 30, 2015

Old crop corn stocks in all positions on September 1, 2015 totaled 57.0 million bushels, up 138 percent from September 1, 2014. On-farm stocks totaled 29.5 million bushels, while off-farm stocks totaled 27.5 million bushels. The June - August 2015 indicated disappearance is 89.7 million bushels, up 54 percent from the same period last year.

Old crop soybean stocks in all positions on September 1, 2015 totaled 13.9 million bushels, up 170 percent from September 1, 2014. On-farm stocks totaled 5.70 million bushels, while off-farm stocks totaled 8.18 million bushels. The June - August 2015 indicated disappearance is 20.3 million bushels, up 54 percent from the same period last year.

All wheat stocks in all positions on September 1, 2015 totaled 31.5 million bushels, down 1 percent from September 1, 2014. On-farm stocks totaled 7.80 million bushels, while off-farm stocks totaled 23.7 million bushels. The June - August 2015 indicated disappearance is 15.1 million bushels, down 26 percent from the same period last year.
