NEBRASKA CROP PROGRESS AND CONDITION

LINCOLN, Neb. October 7, 2019 - For the week ending October 6, 2019, there were 3.2 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 1 percent very short, 7 short, 78 adequate, and 14 surplus. Subsoil moisture supplies rated 1 percent very short, 6 short, 83 adequate, and 10 surplus.

Field Crops Report: Corn condition rated 2 percent very poor, 5 poor, 20 fair, 56 good, and 17 excellent. Corn mature was 74 percent, behind 91 last year and 85 for the five-year average. Harvested was 12 percent, behind 22 last year and 17 average.

Soybean condition rated 1 percent very poor, 4 poor, 21 fair, 62 good, and 12 excellent. Soybeans dropping leaves was 86 percent, behind 95 last year and 93 average. Harvested was 14 percent, well behind 35 last year, and behind 30 average.

Winter wheat planted was 88 percent, near 85 both last year and average. Emerged was 41 percent, behind 56 last year and 60 average.

Sorghum condition rated 1 percent very poor, 2 poor, 16 fair, 66 good, and 15 excellent. Sorghum mature was 75 percent, behind 88 last year and 82 average. Harvested was 4 percent, behind 22 last year and 17 average.

Dry edible beans harvested was 80 percent.

Pasture and Range Report: Pasture and range conditions rated 1 percent very poor, 3 poor, 15 fair, 63 good, and 18 excellent.
