## NEBRASKA CROP PROGRESS AND CONDITION

**LINCOLN, Neb. November 22, 2021** - For the week ending November 21, 2021, there were 6.6 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 8% very short, 30% short, 61% adequate, and 1% surplus. Subsoil moisture supplies rated 11% very short, 38% short, 50% adequate, and 1% surplus.

**Field Crops Report:** Corn harvested was 95%, near 98% last year and 94% for the five-year average.

Winter wheat condition rated 3% very poor, 10% poor, 24% fair, 52% good, and 11% excellent.

Sorghum harvested was 95%, behind 100% last year, but near 94% average.

**Pasture and Range Report:** Pasture and range conditions rated 13% very poor, 15% poor, 55% fair, 15% good, and 2% excellent.
