United States Commercial Slaughter

Commercial red meat production for the United States totaled 4.76 billion pounds in October 2022, up slightly from the 4.75 billion pounds produced in October 2021.

Beef production, at 2.40 billion pounds, was 2 percent above the previous year. Cattle slaughter totaled 2.90 million head, up 2 percent from October 2021.

Veal production totaled 4.50 million pounds, 1 percent below October a year ago. Calf slaughter totaled 30,400 head, down 14 percent from October 2021.

Pork production totaled 2.34 billion pounds, down 1 percent from the previous year. Hog slaughter totaled 10.9 million head, down 1 percent from October 2021.

Lamb and mutton production, at 10.4 million pounds, was down 9 percent from October 2021. Sheep slaughter totaled 169,100 head, 10 percent below last year.

Pacific Region Commercial Slaughter

California's production of red meat during October 2022 totaled 144 million pounds (dressed weight), 1 percent above than October 2021. This figure includes slaughter in Federally-inspected and state-inspected plants, but excludes farm slaughter. In October 2022, the average live weight of cattle slaughtered in California was 1,319 pounds, calves averaged 133 pounds, sheep and lambs averaged 146 pounds, and hogs averaged 263 pounds. In Hawaii, 800,000 pounds of red meat were produced in October 2022.
