According to the National Agricultural Statistics Service in New Jersey, there were 6.5 days suitable for fieldwork for the week ending Sunday, October 15, 2023. Topsoil moisture supplies were 1 percent short, 96 percent adequate and 3 percent surplus. Subsoil moisture supplies were 1 percent short, 89 percent adequate and 10 percent surplus. Pasture conditions were 1 percent poor, 6 percent fair, 92 percent good and 1 percent excellent.
