**Maryland** egg production totaled 68.0 million during March 2020, down 1 percent from last year. Production included 66.6 million table eggs, and 1.4 million hatching eggs. The total number of layers during March 2020 averaged 2.67 million, down 1 percent from last year. March egg production per 100 layers was 2,552 eggs, up slightly percent from March 2019.

**New York** egg production totaled 145.5 million during March 2020, up 1 percent from last year. The total number of layers during March 2020 averaged 5.62 million, up 1 percent from last year. March egg production per 100 layers was 2,591 eggs, down 1 percent from March 2019.

**Pennsylvania** egg production totaled 787.2 million during March 2020, up 8 percent from last year. Production included 756.1 million table eggs, and 31.1 million hatching eggs. The total number of layers during March 2020 averaged about 30.9 million, up 4 percent from last year. March egg production per 100 layers was 2,544 eggs, up 4 percent from March 2019.
