**Maryland** egg production totaled 64.0 million during November 2020, down 3.4 percent from last year. Production included 62.4 million table eggs, and 1.6 million hatching eggs. The total number of layers during November 2020 averaged 2.60 million, down 5.1 percent from last year. November egg production per 100 layers was 2,463 eggs, up 2 percent from November 2019.

**New York** egg production totaled 147.6 million during November 2020, up 2 percent from last year. The total number of layers during November 2020 averaged 5.83 million, up 0.8 percent from last year. November egg production per 100 layers was 2,532 eggs, up 1.2 percent from November 2019.

**Pennsylvania** egg production totaled 749.3 million during November 2020, down 2.2 percent from last year. Production included 721.4 million table eggs, and 27.9 million hatching eggs. The total number of layers during November 2020 averaged about 30.6 million, down slightly 0.2 percent from last year. November egg production per 100 layers was 2,448 eggs, down 2 percent from November 2019.
