Maryland egg production totaled 56.4 million during October 2023, down 6 percent from last year. Production included 55.0 million table eggs, and 1.4 million hatching eggs. The total number of layers during October 2023 averaged 2.14 million, down 5 percent from last year. October egg production per 100 layers was 2,637 eggs, down 2 percent from October 2022.

New York egg production totaled 147.3 million during October 2023, down 1 percent from last year. The total number of layers during October 2023 averaged 5.68 million, down 1 percent from last year. October egg production per 100 layers was 2,593 eggs, down slightly from October 2022.

Pennsylvania egg production totaled 704.9 million during October 2023, up 5 percent from last year. Production included 662.2 million table eggs, and 42.7 million hatching eggs. The total number of layers during October 2023 averaged about 27.8 million, up 7 percent from last year. October egg production per 100 layers was 2,538 eggs, down 2 percent from October 2022.
