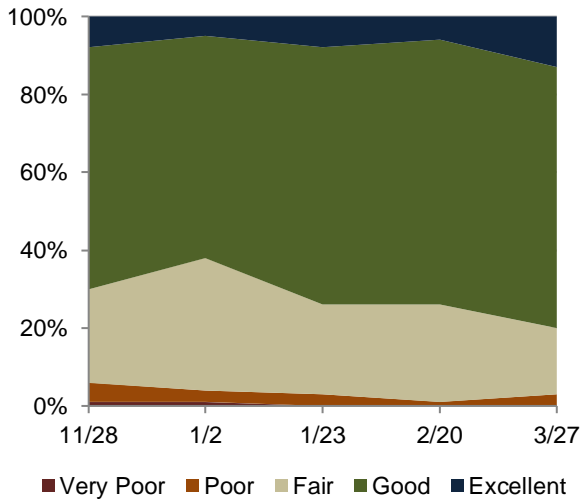

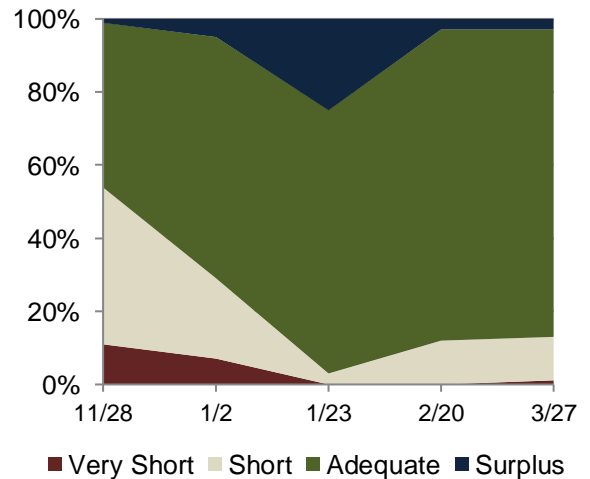

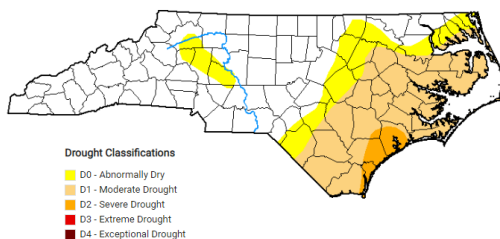
### WINTER WHEAT CONDITION



### TOPSOIL MOISTURE PERCENT

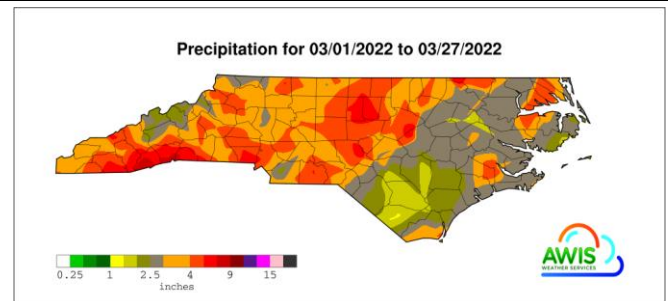


Map depicts current drought conditions as of March 22, 2022.
