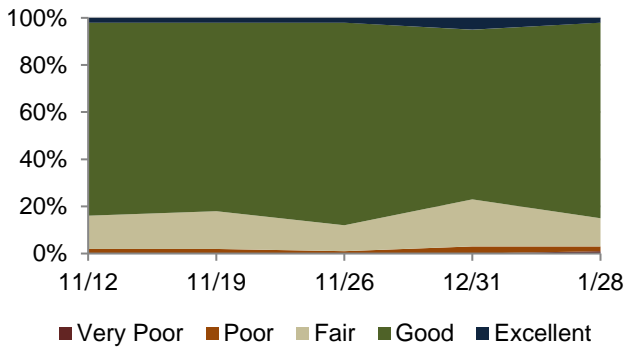

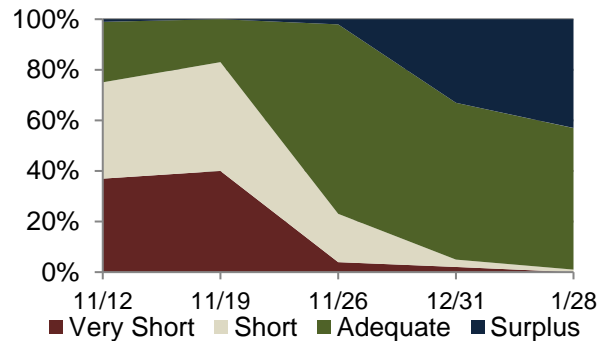

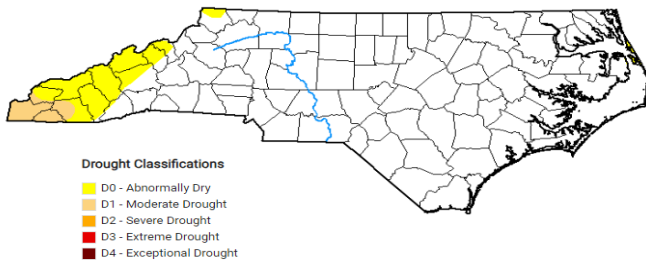
BARLEY CONDITION



TOPSOIL MOISTURE PERCENT

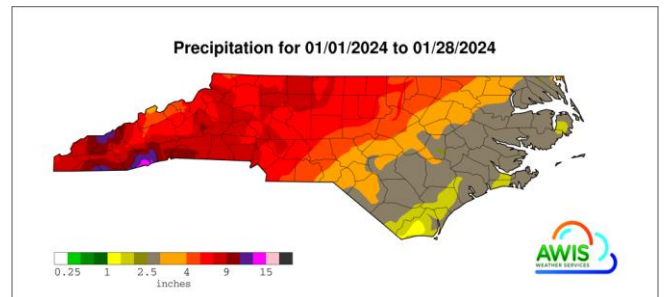


Map depicts current drought conditions as of January 23, 2024.
