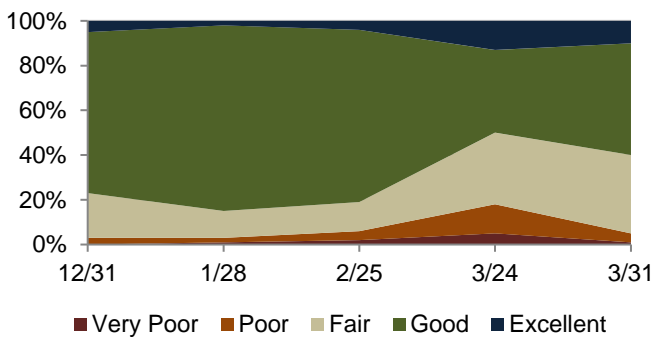

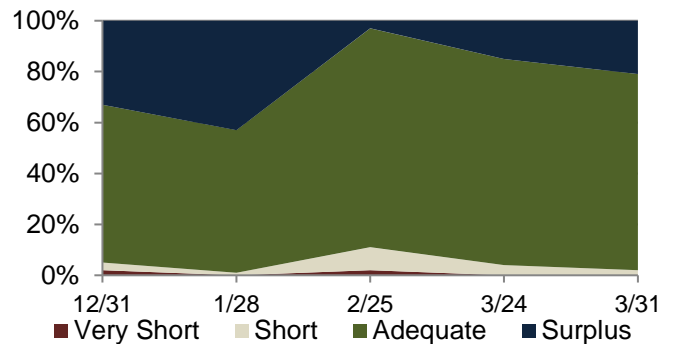

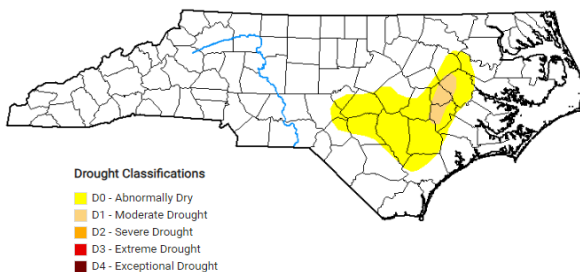

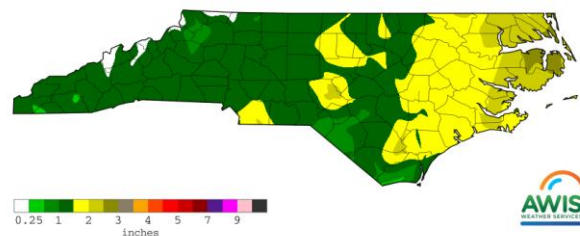
TOPSOIL MOISTURE PERCENT
