









WHEAT STOCKS (Thousand Bushels)




CORN STOCKS (Thousand Bushels)



MONTHLY PRICE RECEIVED FOR SOYBEANS




MONTHLY PRICE RECEIVED FOR CORN








SOWS FARROWING

North Carolina producers intend to farrow 385,000 sows during the September – November 2025 quarter and 380,000 sows during the December 2025 - February 2026 quarter.

PIG CROP

The State's pig crop during the June - August 2025 period totaled 4.505 million head, down 5% from the same period last year. These pigs were produced by 385,000 sows.

PIGS PER LITTER

Pigs saved per litter averaged 11.70 during the June - August 2025 quarter, which is up from the 11.60 pigs saved during the same quarter last year.

HOGS & PIGS TOTAL INVENTORY

The total inventory (includes breeding and market hogs) of hogs and pigs on North Carolina farms on September 1, 2025, totaled 7.8 million head, up 3% from last quarter and down 4% from last year. Market hogs, at 7.04 million head, are down 4% from last year.

North Carolina currently ranks 3rd nationally, behind Iowa and Minnesota, in the total inventory of hogs and pigs on farms as of September 1, 2025.

North Carolina's Pig Crop currently ranks 2nd nationally, behind Iowa, as of September 1, 2025.
