All Wheat Stocks Stored in Northwest Region Up 2 Percent From March 1, 2023

All wheat stored in all positions on March 1, 2024 totaled 44.4 million bushels in Idaho, up from 42.0 million bushels a year ago. Off-farm stocks were up 14 percent, while on-farm stocks were down 6 percent compared to the previous year. In Oregon, wheat stored in all positions totaled 25.0 million bushels, up from 22.7 million bushels a year ago. Off-farm stocks were up 9 percent, while on-farm stocks were up 17 percent compared to the previous year. In Washington, wheat stored in all positions totaled 81.7 million bushels, down from 84.0 million bushels a year ago. Off-farm stocks were down slightly, while on-farm stocks were down 37 percent compared to the previous year. Nationally, wheat stored in all positions totaled 1.09 billion bushels, up from 941 million bushels a year ago. Off-farm stocks were up 14 percent, while on-farm stocks were up 20 percent compared to the previous year.

Barley stocks in all positions on March 1, 2024 totaled 27.0 million bushels in Idaho, up from 25.6 million bushels a year ago. Off-farm stocks were down 5 percent, while on-farm stocks were up 22 percent compared to the previous year. In Oregon, barley stored in all positions totaled 746,000 bushels, down from 858,000 bushels a year ago. On-farm stocks were 250,000 bushels, down 42 percent compared to the previous year. Off farm stocks were 496,000 bushels, up 16 percent from the previous year. In Washington, barley stored in all positions totaled 3.70 million bushels, up from 2.79 million a year ago. Off-farm stocks were up 32 percent bushels, while on-farm stocks were up 36 percent compared to the previous year. Nationally, barley stored in all positions totaled 111 million bushels, up from 88.7 million bushels from a year ago. Off-farm stocks were up 8 percent, while on-farm stocks were up 51 percent compared to the previous year.

Oats stored in off-farm locations on March 1, 2024 totaled 108,000 bushels in Idaho, down from 235,000 bushels a year ago. In Oregon, oats stored in off-farm locations on March 1, 2024 totaled 205,000 bushels, down 33 percent from a year ago. In Washington, oat stored in all positions totaled 87,000 bushels, up from 68,000 bushels a year ago. Nationally, oats stored in all positions totaled 51.6 million bushels, up from 42.9 million bushels a year ago. Off-farm stocks were 35.3 million, up 37 percent from the previous year, while on-farm stocks were 16.3 million, down 5 percent compared to the previous year.


Corn stored in off-farm locations on March 1, 2024 totaled 4.61 million bushels in Idaho, up from 3.79 million bushels a year ago. In Oregon, corn stored in off-farm locations totaled 1.09 million bushels, up 258 percent from a year ago. In Washington, corn stored in off-farm locations totaled 6.29 million bushels, down 39 percent from a year ago. Nationally, corn stored in all positions totaled 8.35 billion bushels, up from 7.40 billion bushels a year ago. Off-farm stocks were 3.27 billion bushels, down 1 percent, while on-farm stocks were 5.08 billion, up 24 percent compared to the previous year.
