**Maryland** egg production totaled 64.2 million during May 2021, down 4.9 percent from last year. Production included 62.5 million table eggs, and 1.7 million hatching eggs. The total number of layers during May 2021 averaged 2.51 million, down 5.2 percent from last year. May egg production per 100 layers was 2,554 eggs, up 0.4 percent from May 2020.

**New York** egg production totaled 147.8 million during May 2021, up 0.7 percent from last year. The total number of layers during May 2021 averaged 5.82 million, up 4.3 percent from last year. May egg production per 100 layers was 2,542 eggs, down 3.4 percent from May 2020.

**Pennsylvania** egg production totaled 750.7 million during May 2021, down 3.2 percent from last year. Production included 726.6 million table eggs, and 24.1 million hatching eggs. The total number of layers during May 2021 averaged about 29.2 million, down 4.2 percent from last year. May egg production per 100 layers was 2,570 eggs, up 1.1 percent from May 2020.
