**Maryland** egg production totaled 45.4 million during March 2022, down 29 percent from last year. Production included 44.1 million table eggs, and 1.3 million hatching eggs. The total number of layers during March 2022 averaged 1.79 million, down 29 percent from last year. March egg production per 100 layers was 2,531 eggs, down slightly from March 2021.

**New York** egg production totaled 149.0 million during March 2022, down slightly from last year. The total number of layers during March 2022 averaged 5.71 million, down 2 percent from last year. March egg production per 100 layers was 2,608 eggs, up slightly from March 2021.

**Pennsylvania** egg production totaled 771.2 million during March 2022, up 12 percent from last year. Production included 733.5 million table eggs, and 37.7 million hatching eggs. The total number of layers during March 2022 averaged about 29.3 million, down 3 percent from last year. March egg production per 100 layers was 2,636 eggs, up 16 percent from March 2021.
