SOUTH DAKOTA CROP PROGRESS AND CONDITION

SIOUX FALLS, S.D. June 14, 2021 - For the week ending June 13, 2021, there were 6.2 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 36% very short, 44% short, 20% adequate, and 0% surplus. Subsoil moisture supplies rated 32% very short, 47% short, 21% adequate, and 0% surplus.

Field Crops Report: Corn condition rated 4% very poor, 9% poor, 42% fair, 43% good, and 2% excellent. Corn emerged was 96%, near 97% last year, but ahead of 87% for the five-year average.

Soybean condition rated 3% very poor, 9% poor, 43% fair, 42% good, and 3% excellent. Soybeans emerged was 94%, ahead of 83% last year, and well ahead of 73% average.

Winter wheat condition rated 16% very poor, 26% poor, 36% fair, 22% good, and 0% excellent. Winter wheat headed was 89%, ahead of 75% last year and 76% average.

Spring wheat condition rated 8% very poor, 18% poor, 57% fair, 17% good, and 0% excellent. Spring wheat headed was 45%, well ahead of 19% last year, and ahead of 26% average.

Oats condition rated 7% very poor, 16% poor, 49% fair, 28% good, and 0% excellent. Oats headed was 54%, well ahead of 21% last year and 32% average.

Sorghum condition rated 1% very poor, 10% poor, 74% fair, 13% good, and 2% excellent. Sorghum planted was 94%, ahead of 84% last year and 82% average. Headed was 3%.

Sunflowers planted was 79%, ahead of 68% last year and 65% average.

Pasture and Range Report: Pasture and range conditions rated 18% very poor, 36% poor, 36% fair, 8% good, and 2% excellent.
