SOUTH DAKOTA CROP PROGRESS AND CONDITION

SIOUX FALLS, S.D. November 15, 2021 - For the week ending November 14, 2021, there were 4.8 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 9% very short, 23% short, 63% adequate, and 5% surplus. Subsoil moisture supplies rated 12% very short, 33% short, 53% adequate, and 2% surplus.

Field Crops Report: Corn harvested was 89%, behind 95% last year, but ahead of 79% for the five-year average.

Winter wheat condition rated 6% very poor, 20% poor, 41% fair, 31% good, and 2% excellent.

Sorghum harvested was 93%, behind 98% last year, but ahead of 86% average.

Sunflowers harvested was 83%, near 80% last year, and ahead of 73% average.

Pasture and Range Report: Pasture and range conditions rated 31% very poor, 37% poor, 22% fair, 9% good, and 1% excellent.
