## SOUTH DAKOTA CROP PROGRESS AND CONDITION

**SIoux FALLS, S.D. April 11, 2022** - For the week ending April 10, 2022, there were 3.7 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 20% very short, 44% short, 33% adequate, and 3% surplus. Subsoil moisture supplies rated 20% very short, 46% short, 33% adequate, and 1% surplus.

**Field Crops Report:** Winter wheat condition rated 1% very poor, 19% poor, 58% fair, 21% good, and 1% excellent.

Spring wheat planted was 15%, behind 27% last year, but near 12% for the five-year average.

Oats planted was 16%, near 18% last year, but ahead of 9% average. Emerged was 1%, near 2% last year, and equal to average.
