## SOUTH DAKOTA CROP PROGRESS AND CONDITION

**SIOUX FALLS, S.D. November 21, 2022** - For the week ending November 20, 2022, there were 4.8 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 43% very short, 42% short, 15% adequate, and 0% surplus. Subsoil moisture supplies rated 40% very short, 40% short, 20% adequate, and 0% surplus.

**Field Crops Report:** Winter wheat condition rated 6% very poor, 26% poor, 36% fair, 31% good, and 1% excellent. Winter wheat emerged was 88%, behind 95% last year, and near 92% average.

Sunflowers harvested was 96%, ahead of 89% last year and 77% average.

**Pasture and Range Report:** Pasture and range conditions rated 36% very poor, 25% poor, 28% fair, 11% good, and 0% excellent.
