SOUTH DAKOTA CROP PROGRESS AND CONDITION

SIOUX FALLS, S.D. June 26, 2023 - For the week ending June 25, 2023, there were 5.0 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 15% very short, 36% short, 46% adequate, and 3% surplus. Subsoil moisture supplies rated 17% very short, 43% short, 38% adequate, and 2% surplus.

Field Crops Report: Corn condition rated 4% very poor, 13% poor, 36% fair, 44% good, and 3% excellent.

Soybean condition rated 2% very poor, 11% poor, 40% fair, 44% good, and 3% excellent. Soybeans blooming was 7%, near 5% for the five-year average.

Winter wheat condition rated 22% very poor, 21% poor, 36% fair, 20% good, and 1% excellent. Winter wheat headed was 93%, near 92% both last year and average.

Spring wheat condition rated 11% very poor, 22% poor, 40% fair, 25% good, and 2% excellent. Spring wheat headed was 70%, well ahead of 41% last year, and ahead of 53% average.

Oats condition rated 7% very poor, 18% poor, 36% fair, 36% good, and 3% excellent. Oats headed was 83%, well ahead of 54% last year and 63% average.

Sorghum condition rated 2% very poor, 7% poor, 37% fair, 51% good, and 3% excellent. Sorghum headed was 14%, ahead of 2% both last year and average.

Sunflower condition rated 2% very poor, 4% poor, 50% fair, 42% good, and 2% excellent. Sunflowers planted was 97%, near 95% last year, and ahead of 92% average. Emerged was 62%.

Pasture and Range Report: Pasture and range conditions rated 10% very poor, 16% poor, 43% fair, 27% good, and 4% excellent.
