## SOUTH DAKOTA CROP PROGRESS AND CONDITION

**SIOUX FALLS, S.D. July 3, 2023** - For the week ending July 2, 2023, there were 5.7 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 17% very short, 34% short, 46% adequate, and 3% surplus. Subsoil moisture supplies rated 16% very short, 36% short, 44% adequate, and 4% surplus.

**Field Crops Report:** Corn condition rated 3% very poor, 9% poor, 39% fair, 42% good, and 7% excellent. Corn silking was 1%, equal to the five-year average.

Soybean condition rated 4% very poor, 10% poor, 38% fair, 43% good, and 5% excellent. Soybeans blooming was 13%, near 9% last year, and equal to average.

Winter wheat condition rated 23% very poor, 23% poor, 28% fair, 25% good, and 1% excellent. Winter wheat headed was 98%, near 99% last year, and equal to average. Harvested was 1%.

Spring wheat condition rated 11% very poor, 22% poor, 41% fair, 23% good, and 3% excellent. Spring wheat headed was 89%, well ahead of 61% last year, and ahead of 71% average.

Oats condition rated 7% very poor, 20% poor, 32% fair, 35% good, and 6% excellent. Oats headed was 94%, well ahead of 72% last year, and ahead of 78% average.

Sorghum condition rated 4% very poor, 10% poor, 31% fair, 52% good, and 3% excellent. Sorghum headed was 20%, ahead of 4% both last year and average.

Sunflower condition rated 0% very poor, 3% poor, 40% fair, 55% good, and 2% excellent. Sunflowers emerged was 75%.

**Pasture and Range Report:** Pasture and range conditions rated 10% very poor, 14% poor, 37% fair, 34% good, and 5% excellent.
