## SOUTH DAKOTA CROP PROGRESS AND CONDITION

**SIOUX FALLS, S.D. September 5, 2023** - For the week ending September 3, 2023, there were 6.9 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 14% very short, 35% short, 48% adequate, and 3% surplus. Subsoil moisture supplies rated 14% very short, 38% short, 45% adequate, and 3% surplus.

**Field Crops Report:** Corn condition rated 6% very poor, 14% poor, 36% fair, 35% good, and 9% excellent. Corn dough was 93%, near 91% last year and 92% for the five-year average. Dented was 62%, ahead of 52% last year and 55% average. Mature was 9%, equal to last year, and near 12% average.

Soybean condition rated 5% very poor, 12% poor, 37% fair, 38% good, and 8% excellent. Soybeans setting pods was 96%, equal to both last year and average. Dropping leaves was 21%, ahead of 11% last year, and equal to average.

Winter wheat planted was 8%, ahead of 2% both last year and average.

Spring wheat harvested was 97%, near 96% last year and 95% average.

Oats harvested was 100%, ahead of 95% last year, and near 97% average.

Sorghum condition rated 3% very poor, 8% poor, 40% fair, 42% good, and 7% excellent. Sorghum coloring was 74%, ahead of 68% last year and 62% average. Mature was 8%, behind 25% last year, and near 11% average.

Sunflower condition rated 2% very poor, 5% poor, 47% fair, 42% good, and 4% excellent. Sunflowers blooming was 98%. Ray flowers dry was 40%. Bracts turned yellow was 5%.

**Pasture and Range Report:** Pasture and range conditions rated 8% very poor, 14% poor, 31% fair, 36% good, and 11% excellent.
