## SOUTH DAKOTA CROP PROGRESS AND CONDITION

**SIOUX FALLS, S.D. October 30, 2023** - For the week ending October 29, 2023, there were 4.4 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 5% very short, 17% short, 71% adequate, and 7% surplus. Subsoil moisture supplies rated 7% very short, 27% short, 63% adequate, and 3% surplus.

Field Crops Report: Corn harvested was 60%, behind 79% last year, but near 58% for the five-year average.

Soybeans harvested was 94%, near 96% last year, but ahead of 86% average.

Winter wheat condition rated 3% very poor, 5% poor, 33% fair, 45% good, and 14% excellent. Winter wheat planted was 97%, near 99% last year and 98% average. Emerged was 79%, ahead of 67% last year, but near 81% average.

Sorghum harvested was 77%, equal to last year, and ahead of 62% average.

Sunflower condition rated 2% very poor, 7% poor, 45% fair, 42% good, and 4% excellent. Sunflowers bracts turned brown was 98%. Harvested was 34%, well behind 56% last year, and near 37% average.

**Pasture and Range Report:** Pasture and range conditions rated 4% very poor, 10% poor, 33% fair, 44% good, and 9% excellent.
