SOUTH DAKOTA CROP PROGRESS AND CONDITION

SIOUX FALLS, S.D. May 6, 2024 - For the week ending May 5, 2024, there were 2.1 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 1% very short, 7% short, 75% adequate, and 17% surplus. Subsoil moisture supplies rated 2% very short, 12% short, 80% adequate, and 6% surplus.

Field Crops Report: Corn planted was 18%, near 19% last year and 22% for the five-year average. Emerged was 1%, equal to average.

Soybeans planted was 10%, near 7% last year and 9% average.

Winter wheat condition rated 1% very poor, 2% poor, 28% fair, 61% good, and 8% excellent.

Spring wheat planted was 79%, well ahead of 45% last year and 54% average. Emerged was 31%, well ahead of 6% last year, and ahead of 21% average.

Oats planted was 75%, well ahead of 47% last year and 55% average. Emerged was 38%, well ahead of 10% last year, and ahead of 23% average.

Sorghum planted was 16%, ahead of 4% last year and 3% average.

Pasture and Range Report: Pasture and range conditions rated 3% very poor, 4% poor, 23% fair, 65% good, and 5% excellent.
