SOUTH DAKOTA CROP PROGRESS AND CONDITION

SIoux FALLS, S.D. June 17, 2024 - For the week ending June 16, 2024, there were 6.0 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 4% very short, 12% short, 74% adequate, and 10% surplus. Subsoil moisture supplies rated 4% very short, 13% short, 73% adequate, and 10% surplus.

Field Crops Report: Corn condition rated 0% very poor, 3% poor, 19% fair, 66% good, and 12% excellent. Corn emerged was 90%, behind 98% last year, but near 88% for the five-year average.

Soybean condition rated 1% very poor, 3% poor, 21% fair, 67% good, and 8% excellent. Soybeans planted was 95%, near 99% last year and 92% average. Emerged was 78%, behind 92% last year, but near 76% average.

Winter wheat condition rated 1% very poor, 4% poor, 25% fair, 57% good, and 13% excellent. Winter wheat headed was 89%, ahead of 80% last year and 75% average.

Spring wheat condition rated 1% very poor, 5% poor, 26% fair, 62% good, and 6% excellent. Spring wheat headed was 28%, behind 41% last year, and equal to average.

Oats condition rated 1% very poor, 2% poor, 19% fair, 69% good, and 9% excellent. Oats headed was 41%, behind 58% last year, but ahead of 36% average.

Sorghum condition rated 0% very poor, 1% poor, 26% fair, 63% good, and 10% excellent. Sorghum planted was 96%, near 95% last year, and ahead of 86% average. Headed was 5%, near 2% last year and 1% average.

Sunflowers planted was 82%, near 84% last year, but ahead of 75% average. Emerged was 26%, behind 37% last year.

Pasture and Range Report: Pasture and range conditions rated 5% very poor, 6% poor, 26% fair, 53% good, and 10% excellent.
