Oklahoma hatcheries set 7.66 million eggs in incubators during the week ending July 10, down 3 percent from the week prior but 1 percent above the previous year.

The number of chicks placed for meat production during the week of July 10, was 4.21 million, up 12 percent from the previous week and up 21 percent from the previous year.

**Texas** hatcheries set 18.1 million eggs in incubators during the week ending July 10, down slightly from the week prior but up 1 percent from the previous vear.

The number of chicks placed for meat production during the week of July 10, was 14.4 million, up 1 percent from the previous week but down 2 percent from the previous year.
