**Oklahoma** hatcheries set 7.32 million eggs in incubators during the week ending October 16, down 1 percent from the week prior and down 4 percent from the previous year.

The number of chicks placed for meat production during the week of October 16, was 3.40 million, down 22 percent from the previous week and down 2 percent from the previous year. **Texas** hatcheries set 17.7 million eggs in incubators during the week ending October 16, up 5 percent from the week prior, but down 1 percent from the previous year.

The number of chicks placed for meat production during the week of October 16, was 13.8 million, up 8 percent from the previous week, but down 6 percent from the previous year.
