

The grain stocks estimates in this report are based on surveys conducted during the first two weeks of September. Data provided by Oklahoma and Texas operators are the foundation of the estimates made for the Southern Plains region. Separate surveys are conducted to obtain the on-farm and off-farm estimates. We would like to thank all operators who responded to the survey. Results from the next quarterly survey will be made available on January 12, 2022

Oklahoma stocks of wheat in all positions on September 1 totaled 127 million bushels, down 5 percent from the 2020 level of 134 million bushels. Off-farm wheat stocks, at 115 million bushels, were 4 percent lower than September 1, 2020. **Texas** stocks of wheat in all positions on September 1, at 87.3 million bushels, were down 7 percent from the 2020 level of 93.6 million bushels. Off-farm wheat stocks, at 80.7 million bushels, were 8 percent lower than September 1, 2020.




Quarterly Wheat Stocks All Positions

Texas off-farm sorghum stocks totaled 7.18 million bushels. On-farm stocks for sorghum totaled 120 thousand bushels on September 1, 2021.


Texas off-farm corn stocks, at 27.7 million bushels, were up 7 percent from last year. On-farm stocks for corn are not published for the state.

Oklahoma off-farm sorghum stocks totaled 666 thousand bushels, down 4 percent September 1, 2020. On-farm stocks for sorghum are not published for the state.

Oklahoma off-farm corn stocks, at 1.26 million bushels, were down 51 percent from a year earlier. On-farm stocks for corn are not published for the state.

U.S. Highlights: Old crop corn stocks in all positions on September 1, 2021 totaled 1.24 billion bushels, down 36 percent from September 1, 2020. All wheat stocks were estimated at 1.78 billion bushels in all positions, down 18 percent from last September. Old crop grain sorghum stored in all positions on September 1, 2021 totaled 20.3 million bushels, down 32 percent from a year ago. Old crop soybeans stored in all positions on September 1, 2021 totaled 256 million bushels, down 51 percent from September 1, 2020.
