**Oklahoma** hatcheries set 7.72 million eggs in incubators during the week ending March 25, up 7 percent from the week prior but down 1 percent the previous year.

The number of chicks placed for meat production during the week of March 25, was 4.35 million, down 15 percent from the previous week but up 22 percent from the previous year. **Texas** hatcheries set 18.3 million eggs in incubators during the week ending March 25, down slightly from the week prior and down 4 percent from the previous year.

The number of chicks placed for meat production during the week of March 25, was 14.4 million, up 1 percent from the previous week but down 4 percent from the previous year.
