Oklahoma hatcheries set 7.54 million eggs in incubators during the week ending April 8, up 14 percent from the week prior but down slightly the previous year.

The number of chicks placed for meat production during the week of April 8, was 4.89 million, down 4 percent from the previous week but up 8 percent from the previous year.

**Texas** hatcheries set 18.5 million eggs in incubators during the week ending April 8, up 1 percent from the week prior and up 1 percent from the previous vear.

The number of chicks placed for meat production during the week of April 8, was 14.9 million, up 3 percent from the previous week and up 3 percent from the previous year.
