Oklahoma hatcheries set 7.52 million eggs in incubators during the week ending April 15, up 4 percent from the week prior but down 1 percent the previous year.

The number of chicks placed for meat production during the week of April 15, was 4.47 million, down 9 percent from the previous week and down 13 percent from the previous year.

Texas hatcheries set 18.2 million eggs in incubators during the week ending April 15, down 2 percent from the week prior and down 3 percent from the previous year.

The number of chicks placed for meat production during the week of April 15, was 14.6 million, down 2 percent from the previous week and down 1 percent from the previous year.
