Oklahoma hatcheries set 7.50 million eggs in incubators during the week ending August 5, down 1 percent from the week prior and down 7 percent from the previous year.

The number of chicks placed for meat production during the week of August 5, was 4.39 million, up 13 percent from the previous week and up 10 percent from the previous year.

Texas hatcheries set 18.6 million eggs in incubators during the week ending August 5, up 2 percent from the week prior but down 2 percent from the previous vear.

The number of chicks placed for meat production during the week of August 5, was 14.9 million, up slightly from the previous week and up 3 percent from the previous year.
