

The grain stocks estimates in this report are based on surveys conducted during the first two weeks of September. Data provided by Oklahoma and Texas producers, as well as licensed grain storage facilities, are the foundation of the estimates made for the Southern Plains region. Separate surveys are conducted to obtain the on-farm and off-farm estimates. We would like to thank everyone who responded to the survey. Results from the next quarterly survey will be available on January 12, 2024.

**Oklahoma** stocks of wheat in all positions on September 1 totaled 104 million bushels, down 24 percent from the 2022 level of 137 million bushels. Off-farm wheat stocks, at 96.8 million bushels, were 26 percent lower than September 1, 2022.


**Texas** stocks of wheat in all positions on September 1, at 56.3 million bushels, were up 37 percent from the 2022 level of 41.0 million bushels. Off-farm wheat stocks, at 47.8 million bushels, were 27 percent higher than September 1, 2022.

**Texas** off-farm sorghum stocks totaled 2.98 million bushels. On-farm stocks for sorghum totaled 270 thousand bushels on September 1, 2023.

**Texas** off-farm corn stocks, at 16.0 million bushels, were down 38 percent from last year. On-farm stocks for corn are not published for the state.




**Oklahoma** off-farm sorghum stocks totaled 637 thousand bushels, off-farm sorghum stocks were not published for September 1, 2022. On-farm stocks for sorghum are not published for the state.

**Oklahoma** off-farm corn stocks, at 1.61 million bushels, were down 54 percent from a year earlier. On-farm stocks for corn are not published for the state.

**U.S. Highlights:** Total stocks of corn in the United States on September 1, 2023 were 1.36 billion bushels, 1 percent lower than September 1, 2022. All wheat stocks were estimated at 1.78 billion bushels in all positions, up slightly from last September. U.S. stocks of sorghum totaled 24.2 million bushels, 49 percent below September 1, 2022. Stocks of soybeans in all positions totaled 268 million bushels, down 2 percent from last year.
