This report contains the results from the December 2023 Hog and Pig Survey. Data provided by Oklahoma and Texas producers are the foundation of the estimates made for the Southern Plains region. We would like to thank all producers who responded to the survey. Results from the next quarterly survey will be made available December 22, 2023.

Oklahoma Highlights


The December 1, 2023 Oklahoma hog and pig inventory, at 2.01 million head, was 8 percent lower than December 2022. The number of **breeding hogs** totaled 390 thousand head, down 100 thousand from last year. The December 1 **market hog** inventory was down 4 percent from a year ago at 1.62 million head, 81 percent of the total hog and pig inventory.

The September 2023-November 2023 Oklahoma **pig crop** totaled 2.24 million head, 6 percent below last year. Pigs per litter averaged 11.2, up 4 percent from the previous year. Sows farrowed during September 2023 through November 2023 totaled 200 thousand head, down 9 percent from last year.

Texas Highlights

The December 1, 2023 Texas hog and pig inventory, at 1.10 million head, was 11 percent lower than December 2022. The number of **breeding hogs** totaled 130 thousand head, down 30 thousand from last year. The December 1 **market hog** inventory was down 9 percent from a year ago at 970 thousand head, 88 percent of the total hog and pig inventory.

The September 2023-November 2023 Texas **pig crop** totaled 864 thousand head, 8 percent above last year. Pigs per litter averaged 12.0, up 20 percent from the previous year. Sows farrowed during September 2023 through November 2023 totaled 72.0 thousand head, down 10 percent from last year.



Southern Plains Hog and Pig Inventory, 2021-23





U.S. Highlights

The U.S. inventory of all hogs and pigs on December 1, 2023, is estimated at 75.0 million head, up slightly from a year ago but down slightly from September 1, 2023. The **breeding hog inventory**, at 6.00 million head, was down 3 percent from last year and down 3 percent from the previous quarter. **Market hog** inventory, at 69.0 million head, was up slightly from last year but down slightly fro

The U.S. **pig crop** for September 2023-November 2023, at 34.6 million, was down slightly from 2022. U.S. producers intend to have 2.90 million sows farrow during the December 2023-February 2024 quarter, down 2 percent from the actual farrowings during the same period last year. Intended farrowings for March 2024-May 2024, at 2.91 million sows, are down 1 percent from the same quarter the year prior.
