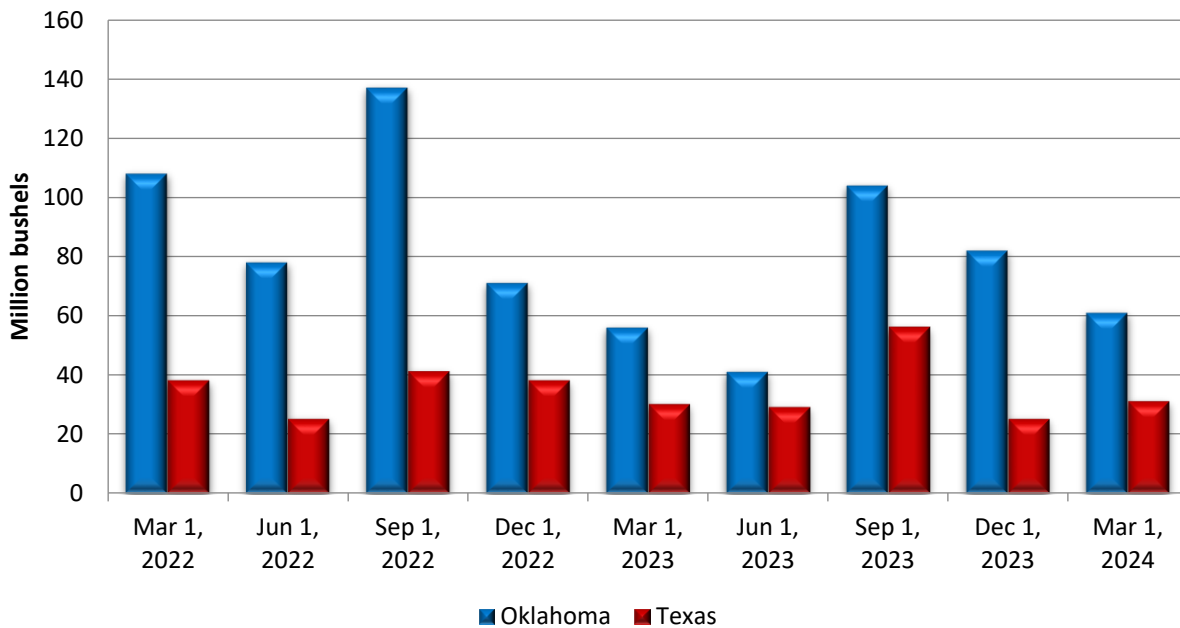

The grain stocks estimates in this report are based on surveys conducted during the first two weeks of March. Data provided by Oklahoma and Texas producers, as well as licensed grain storage facilities, are the foundation of the estimates made for the Southern Plains region. Separate surveys are conducted to obtain the on-farm and off-farm estimates. We would like to thank everyone who responded to the survey. Results from the next quarterly survey will be available on June 28, 2024.

Oklahoma stocks of wheat in all positions on March 1 totaled 61.9 million bushels, up 9 percent from the 2023 level of 56.5 million bushels. Off-farm wheat stocks, at 60.0 million bushels, were up 10 percent from March 1, 2023.

Texas stocks of wheat in all positions on March 1, at 31.8 million bushels, were up 4 percent from the 2023 level of 30.4 million bushels. Off-farm wheat stocks, at 29.9 million bushels, were up 1 percent from March 1, 2023.

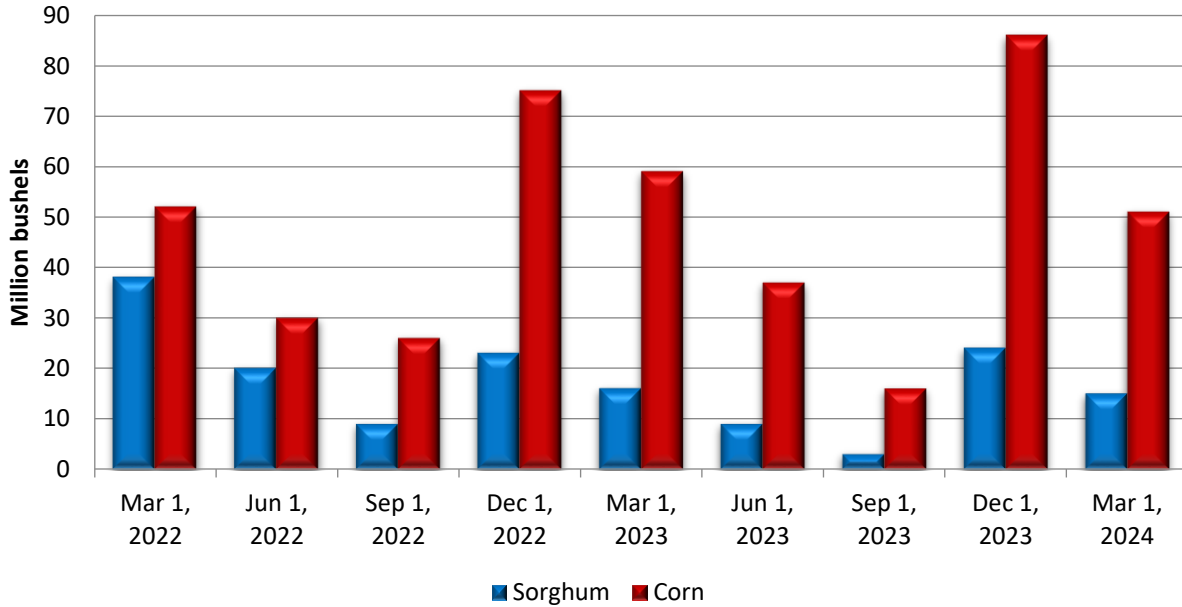
Quarterly Wheat Stocks

Texas off-farm sorghum stocks totaled 15.3 million bushels. On-farm stocks for sorghum totaled 950 thousand bushels on March 1, 2024.

Texas off-farm corn stocks, at 50.6 million bushels, were down 15 percent from last year. On-farm stocks for corn are not published for the state.

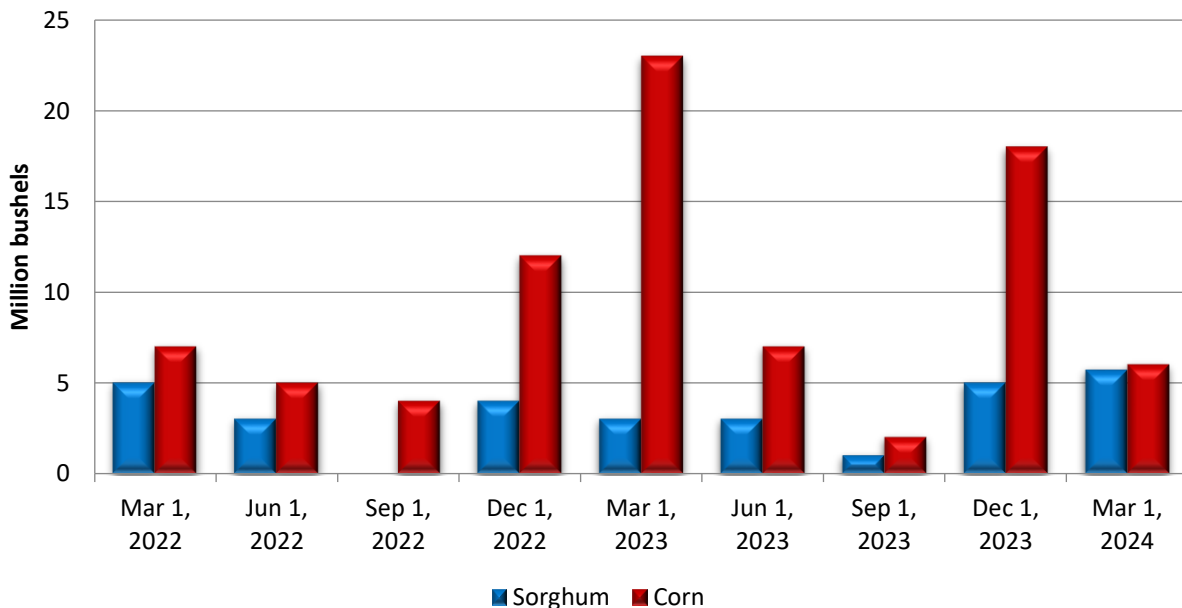
**Texas Quarterly Stocks

Oklahoma off-farm sorghum stocks totaled 5.7 million bushels, up 100 percent from March 1, 2023. On-farm stocks for sorghum are not published for the state.

Oklahoma off-farm corn stocks, at 6.0 million bushels, were down 74 percent from a year earlier. On-farm stocks for corn are not published for the state.

U.S. Highlights: Total stocks of corn in the United States on March 1, 2024 were 8.35 billion bushels, up 13 percent from March 1, 2023. All wheat stocks were estimated at 1.09 billion bushels in all positions, up 16 percent from last March. U.S. stocks of sorghum totaled 106 million bushels, down 3 percent from March 1, 2023. Stocks of soybeans in all positions totaled 1.85 billion bushels, up 9 percent from last year.
