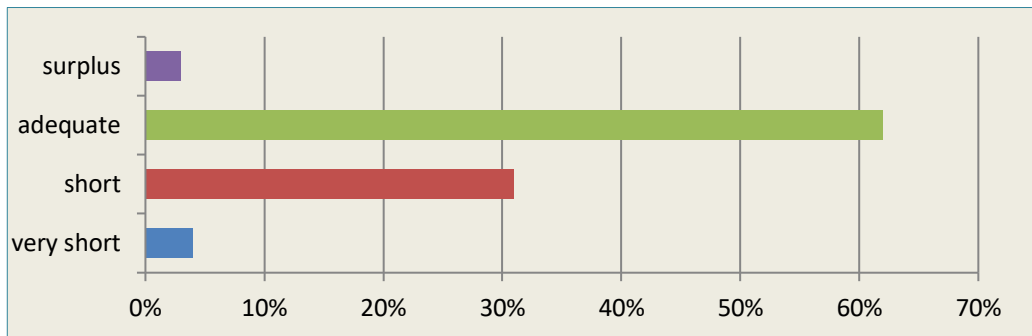

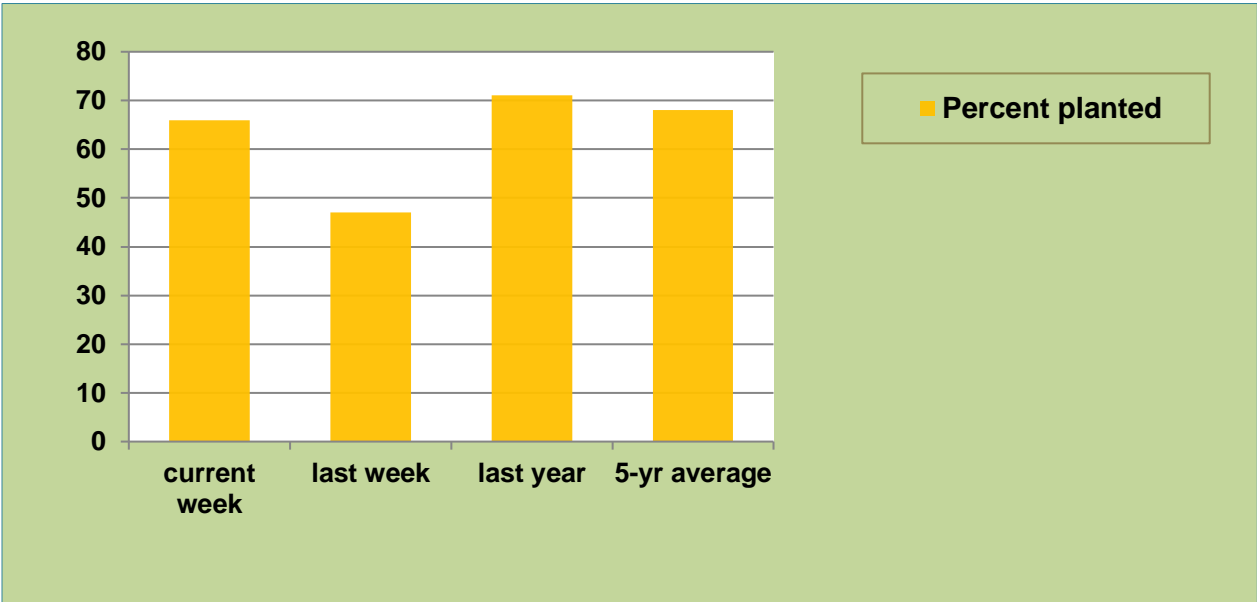

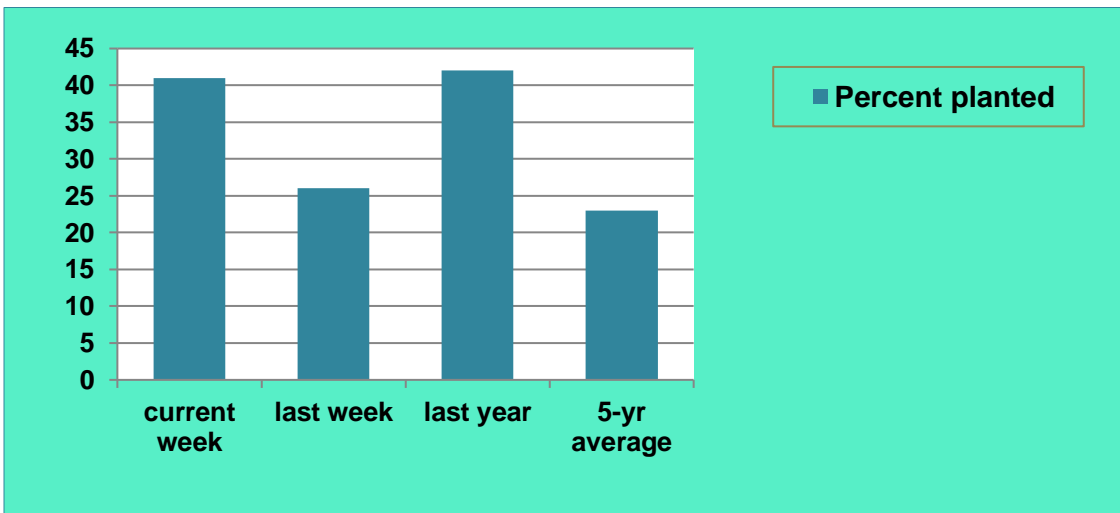

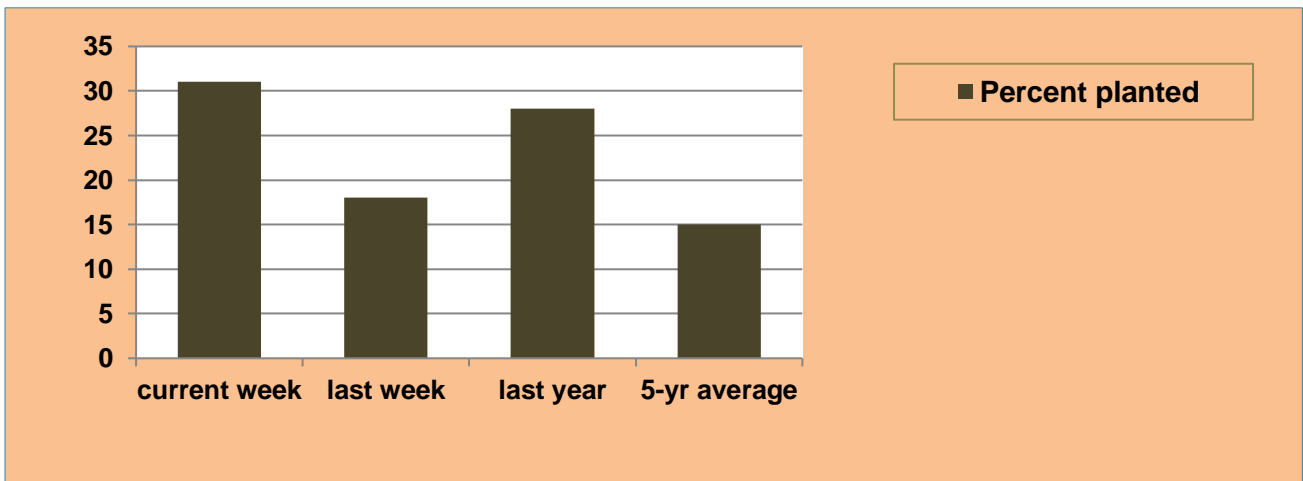
**CORN PLANTED for week ending 5/5/24**
